Dear Parents,

At Holy Cross School, all Holy Cross Parish families participate in the fair share tuition program. Each family is given the cost of educating a student at Holy Cross School, and then is asked to declare, in a fair share tuition contract, their contribution for each child's education. It is expected that each family will participate in the fair share process by declaring their fair share amount at the time of registration and contribute toward their contract on a regular basis. The success of the fair share plan at Holy Cross School has been the total participation of all families.

Students attending Holy Cross School from Catholic parishes outside of Holy Cross Church, but part of the St. Cloud Diocese also participate in the fair share program. A policy of the St. Cloud Diocese requires the home parish of each Catholic school student to be the guarantor of the cost of education not paid by the family. The parish where you are registered is billed for the remaining balance beyond your fair share.

For the 2011-2012 school year, the total cost of educating a child at Holy Cross School is **\$4700.00**. Pre-K tuition is \$1450 for parish members, \$1800.00 for non parish members, plus your fair share of the remaining. Kindergarten tuition is \$1675.00 for parish members, \$1900.00 for non parish members, plus your fair share of the remaining. 1st through 6th grade tuition is \$1350.00 per student, plus your fair share of the remaining. Your 4th child enrolled is free. This cost is based on the expenses and income of the proposed 2011-2012 budget. In Minnesota the average cost of a public school education is over \$9,000 per child. If you can not afford the full tuition price, **you must** schedule a meeting with Fr. Jerry Nordick and Mrs. Moran to make other arrangements. If your contract information is not filled out and turned in, your child is **not** registered for the upcoming school year. We believe we offer an exceptional Catholic educational product for very minimal cost.

We are committed to confidentiality. Under normal circumstances, only the principal is aware of your fair share. In the case of extremely delinquent accounts with no explanation, or lack of a fair share declaration, the school board committee and the finance committee is also consulted. If you choose to share your fair share amount with others, we want you to remember that many times that amount comes under close scrutiny and discussion by others. We don't want your sacrifice, through fair share, to be the subject of gossip. If you experience a family financial emergency that prohibits you from paying your stated contractual pledge, please communicate such emergencies to Father Jerry Nordick and the principal.

Thank you for the tremendous cooperation and sacrifice you are making to provide a Catholic education for your child.
